## **OVERVIEW**

This course will familiarize students with the major theories that explain involvement in crime. We will review classical (early) and contemporary theoretical explanations of crime, examine the empirical evidence for these theories, and discuss application of the theories to criminal justice policies and practices. There will be an emphasis on developing critical thinking skills when evaluating theories. This means that, in addition to understanding the basic facts associated with each theory, we will compare and contrast the assumptions, strengths, weaknesses, and relevance of these theories in class discussions, written assignments, and exams.

#### **OBJECTIVES**

By the end of the semester, you will be able to:

- Summarize each of the major criminological theories in one sentence.
- Explain the processes each theory identifies to explain why individuals become involved in crime and why they may recidivate or desist from offending.
- Understand how theories influence criminal justice policy and practice.
- Identify the strengths and weaknesses of each theory and decide which theory(ies) you think best explains crime.

#### GRADING

- **Exams**: 75% of final grade (25% each).
  - Three non-cumulative exams will be given and will test knowledge in the first, second, and third sections of the class. Each exam will have 50 multiple choice and true/false questions.
  - o <u>Final Exam</u>: The final exam is optional and cumulative, with 50 questions covering content from the entire semester. Students who take the final exam will have their lowest exam score dropped.
- Assignments: 25% of final grade. Assignments will test your understanding of the course content and your ability to apply the material to your own life and to criminal justice policy and practice. Doing well in this part of the course requires you to regularly attend class and complete assignments on time.
  - o <u>In-class assignments</u> will occur throughout the semester, with no advanced warning. Each assignment will be graded as not completed (=0) or completed (=1). *Students must be in class to receive a grade*.
  - Out-of-class assignments require short (< 1 page) responses to a question(s) or activity, as listed on the course schedule and described on the Canvas e-learning site.
