## **Course Description:**

In this course we will cover: the basic foundations of criminal procedural law, to include the application of the US Constitution, the effect and influence of judicial decision makers, and the role of Stare Decisis in the law. We will also cover issues regarding: Fourth Amendment searches and seizures of persons and property; the use and legality of police tactics, such as stop and frisk and interrogations; the legal requirements for reasonable suspicion and probable cause; the level of scientific reliability and the constitutional requirements for evidence presented in a court; the initiation of the legal process, plea bargains, and pretrial procedures and rights; and the procedural requirements and rights during the trial.

## **Course Objectives:**

After taking this course, students should be able to explain the sources of criminal procedural law, the application of the law to them, and the legal limits of their own behavior and the behavior of the police. Students should also be able to explain how these constitutional requirements play into the admissibility of evidence, the basis behind plea bargains, and the function of the trial process to seek the truth.

## **Participation:**

This course will follow the Socratic method. Be prepared to come to class able to participate in class discussions. In your reading assignments, you will be directed to read specific legal cases. As such, to earn full credit for class participation, you must read the cases and chapters that you are assigned and be prepared to answer questions pertaining to the assigned readings out loud in class. You must also submit on canvas the day before class a confirmation that you have read and that you are prepared to be called on in class. If you submit a confirmation, but you are not prepared to discuss the cases when you are called upon, you will receive a zero for participation that day. If that happens, you will not be able to make up the points by completing the discussion.

For those students who are unable to attend class, you may complete a discussion assignment. **You must have permission to submit a discussion in lieu of participating in class.** If you have a legitimate excuse, please speak with your instructor, and you may be given permission to complete the discussions instead of submitting your name. However, even if you have been given permission to complete the discussions, you should still attend class if you are able. Otherwise, you will fall behind in the course.

#### Quizzes:

You will receive two attempts to take each quiz. All the quizzes will be on Canvas. The questions will be different each time, but this is to give you the opportunity to improve your grade by giving you time to go back and study the material. YOU WILL NOT BE GIVEN THE CORRECT ANSWERS. So, you need to know what material and questions you felt less familiar with and focus on that to study before your second attempt. If you have specific questions about what you got wrong or about material you did not understand, you can post in the general discussion for course questions or email the instructor. You can also schedule a meeting or attend my office hours, and I will go through your quiz grade online to allow you to see your answers—and you can ask me questions then about what you got right or wrong.

### Activities:

There will be four activities. The first activity will be an individual assignment; however, the following three are group assignments; so, you must work with your groups to complete them. A link to the activity will be provided at the beginning of each module section (Lessons 1, 4, 7, and 10). You and/or your group will have the entire time over the course of the module section to complete the activities. Exact due dates will be available on Canvas.

- The first activity will be a case brief. You will be given a link to a case, which you must read, attempt to understand, and summarize IN YOUR OWN WORDS.
- The next three group activities will try to force you to think and write like a lawyer. Treat these assignments as if your group is composing a legal memorandum to share within your firm to discuss the potential case for and against your client. You will be given a fact scenario, which you must read and try to spot the various legal issues we have discussed during the course. Each activity will focus on the law we covered in class during the current module section. You will be required to discuss the relevant case law and how it applies to the given facts. The exact details and grading instructions will be available on the assignment and on Canvas in the rubric.

#### Exams:

You will only get one attempt to take the exam. You will need to download and install Respondus Lockdown Browser. A link to that software will be made available on Canvas. Just go to the home page and click on the "start here" button. Again, after you submit your exam, YOU WILL NOT BE GIVEN THE CORRECT ANSWERS. So, you need to know what material and questions you felt less familiar with when taking the quizzes and focus on that to study before you take the exam. If you have specific questions about what you got wrong or about material you did not understand on the exam, you can post in the general discussion for course questions or email the instructor.
