## **Teaching and mentoring**

My teaching philosophy has roots in my education at land-grant universities and was bolstered by my service as a U.S. Peace Corps Volunteer. As an interdisciplinary, applied social scientist conducting research and teaching on complex socio-ecological problems, I use research and case studies from around the world in an active learning environment to give students the knowledge to interpret and critically evaluate complex and nuanced contemporary issues in conservation and environmental justice. My teaching follows an experiential, multi-method approach that aims to engage students in academic literature while also keeping them in discussion with current events, media, and experiences beyond the classroom. Overall, I have prepared four courses since arriving at UF, including the creation of two new undergraduate courses and one new graduate course that explores contemporary and pertinent issues in conservation criminology and environmental justice.
