**Course description and objectives**

This course has two main objectives. First, because cleaning, preparing, and documenting data is essential before any analysis can take place, the course introduces students to key strategies for preparing quantitative data—transforming “raw” information into an analysis-ready dataset. Second, students will learn to conduct research using multiple regression analysis with the Stata statistical software package. We will begin with a brief review of univariate and bivariate statistics, but most of the semester will be devoted to discussing and practicing regression analysis with real data. Throughout the course, we will emphasize the assumptions underlying regression models, the consequences of violating those assumptions, and methods for addressing such violations. Topics will include dummy variables, nonlinear effects, interaction effects, and mediating effects.

Course objectives include the following:

1. Develop skills in cleaning and preparing quantitative data for analysis.
2. Apply regression techniques to real datasets and interpret analytical results.
3. Understand regression model assumptions and the consequences of violating those assumptions, and methods for addressing such violations.
4. Understand mediation and moderation effects and statistically test their impact.

3. Term paper (50% of grade). Each student is required to submit a term paper on any topic that interests you within the field of criminology and criminal justice. You will determine the topic of the paper, but it must be approved by me no later than the date noted in the course schedule. The paper must be of graduate student quality, about 25 pages double spaced, and formatted in accordance with the standards of a major social science journal (e.g. Criminology, JRCD, JQ, JQC, etc). Though the substantive topic of the paper is up to you, it must employ the statistical methods that we cover in the course. More detailed instructions and guidelines will be provided later in the semester. The completed paper must be uploaded on Canvas no later than the due date noted in the course schedule.
